- Compliance with the EPFL Ethical Charter and the Directive on the recognition of student associations.
- Headquarters at EPFL or in the region.

5 Logistical and Budgetary Needs

USC requires the following resources to carry out its activities:

- Access to facilities on the EPFL campus for surfing practice and event organization.
- Collaboration with SKIL to benefit from its resources and logistical support.
- Budget for the purchase and maintenance of surfing equipment, as well as for event organization.

The association's expenses will be covered by member dues, potential grants, and revenues generated from organized events.
